Objective

The Manager Projects is responsible for overseeing the delivery of Fiji Airports' capital and operational projects, ensuring projects are planned, coordinated, and controlled to achieve approved scope, time, cost, safety, and compliance outcomes while managing impacts on live airport operations. This role reports to the Senior Project Manager.
